# 'Basketball is in our blood'

Chris Flakus believes that giving back to the community

is an essential responsibility of any corporation.

As CEO of Jacksonville-based CSI Companies – a leader in providing workforce recruiting, technology, IT consulting and staffing solutions nationwide – Flakus recognizes the significant role UNF plays in developing talent for the region and beyond. His company currently

has 37 Ospreys on staff, 16 of whom were studentathletes. "UNF is highly regarded academically," said Flakus, who graduated from UNF in 1989. "So many students fall in love with Jacksonville, and they want to stay here. For us, we offer a great working environment.We want people to stay here for a long time."

CSI leadership also has a strong connection to college basketball. Flakus played on the West Coast before finishing his degree at UNF, and CFO Josh Bowling was a member of UNF's men's basketball team from 2000-2004. When approached for an opportunity to support the University, the timing and mission of both parties aligned like a buzzer beater!

Bowling, who received a bachelor's and master's degree at UNF, and Flakus both had vested interests in renovating parts of the UNF Arena to enrich the



sporting experience for athletes, students and fans. "Basketball is in our blood, in our DNA, and hiring athletes is in our DNA," Flakus said.

This seven-year partnership will see CSI Companies funding facility improvements, starting with the replacement of the original floor, now renamed the CSI Companies Court. The new court features a state of Florida cutout with a star on Jacksonville, as well as Ospreys branding and the CSI Companies logo.

Flakus said the partnership gives CSI an opportunity to market the company in an impactful way, while also enhancing the student-athlete experience and bringing new excitement to the UNF Arena. "You look at UNF, and you see so much untapped potential," Flakus said. "There's a lot more that can be done down the road."

Flakus invites other companies to give to UNF Athletics, paving the way for better facilities that will impact revenue, recruitment and retention. "We'd like to set the bar," Flakus said. "We really hope to encourage other companies to get involved, whether it's at this level or not."

Flakus said he and the CSI Companies leadership are confident in the missions of both President Moez Limayem and Athletic Director Nick Morrow to trans-form UNF's Athletics programs, allowing the University

to reach new heights in all areas in the future.

"There's such an opportunity to make money for the University through athletics," Flakus said. "You've got to get more crowds and more people coming on campus. Then things will build upon that."

## Helping students thrive

For 15 years, Drs. Jay Dutton and Paul Schilling have helped UNF transform the lives of students and create an environment where all feel a sense of belonging and validation.

The couple of 30 years supports philanthropy that will have an immediate impact. "We look for things that are going to change lives in this generation, and in the here and now," Schilling said.

Their early support of UNF's LGBTQ Center has provided director-level leadership and allowed the Center to expand and flourish. UNF is nationally recognized by Campus Pride among the "Best of the Best" universities in the nation to provide a safe and welcoming environment for LGBTQ+ students and is the only university in Florida to receive this recognition.

Dutton and Schilling continue to change lives through their generosity by providing scholarships to students who have experienced homelessness or who have come through the foster care system. These students are supported by The Nesting Place and receive tuition waivers through the State of Florida, but need help filling the gap to cover expenses for food, housing, books, and supplies. To date, scholarships have been awarded to more than 40 students

"We have benefited from learning about their lives, coping skills and the obstacles they have overcome, and have been stunned by the students' determination amid adversity," Dutton said. "When you hear some of the stories, we are amazed at how they have been able to come this far," Dutton shared. "We look forward to future stories of personal success as well!"

Dutton and Schilling have a long history of helping to address pressing needs of vulnerable individuals, having supported domestic violence centers, homeless programs and LGBTQ nonprofits. Their gifts to the LGBTQ Center at UNF have provided critical resources and given students a greater sense of community and camaraderie to embrace their identities during a formative period of their lives.

UNF's strong community involvement and quality of education and the role UNF plays preparing students for the next chapter of their lives attracted the pair to do more. "What's the best thing about a UNF graduate? They're ready to work in the real world," Dutton said.

Dutton and Schilling both hope by lifting up students, more can realize their full potential with less stress about housing or their next meal. "The overwhelming message from quite a few of the students was that had it not been for this program, they would not have been able to go to school," Dutton said. "That was a very powerful message."

Schilling hopes their philanthropy can inspire others to also give to support students. "We can make a generational change in certain people's lives," he said. "Just a few good changes, a few people at a time."

## Partnering for next-level healthcare

A new partnership is making critical training possible to immediately improve local healthcare in the region. The University of North Florida and HCA Florida Healthcare have partnered to address the growing needs in Florida for well-trained nurses and healthcare professionals.

HCA Florida Healthcare, a leader in hospital management that includes Memorial Hospital Jacksonville, Orange Park Medical Center and others, has joined the University to launch the HCA Healthcare Center for Clinical Advancement, a vital training resource for nursing students via an interdisciplinary, state-ofthe-art simulation center. The new Center spans over 22,000 square feet and features simulation rooms for different medical scenarios. There are six hospital patient rooms, two healthcare settings, an operating room, a six-bay skills/trauma lab, six debriefing/counseling rooms and several classrooms. The lab is housed at FSCJ Deerwood in the UNF MedNexus facility, which was funded through an appropriation from the Florida legislature.

Students will learn vital skills in operating and emergency rooms, as well as techniques and practice in pediatrics, birthing and trauma cases. Each room uses "manikins" that can replicate scenarios and experiences from a real-world hospital setting, allowing varied and expansive instruction. Hugh Tappan, president of HCA Healthcare's South Atlantic Division and a UNF alum, knows the quality of the programs that the Brooks College of Health provides and the value of these modern, simulated training facilities. Previously, simulation has included live actors, but the use of "manikins" provides greater training versatility that fulfills the industry's high-tech, standardized education needs. Tappan shared that there's a great concern in the healthcare field regard

ing outbreaks and the ability to effectively meet both current and future needs.

He believes the transformational training experiences will be safe, effective and enriching for Brooks College of Health students, and he loves that the simulation center brings all different areas of hospital care into a single location to provide training that covers the gamut of healthcare needs. "Nurses are tasked with a tremendous number of responsibilities right now," he said. "It's nurses who are making a difference in all of our lives."

Tappan also appreciates the fact that students will build close connections with their peers and instructors at the Center, something he valued during his time at UNF.

### Giving tech students a pathway to success

The University of North Florida and VyStar Credit Union share a commitment to preparing students for successful careers in STEM and information technology. That enthusiasm has led to the formation of an IT Practicum internship program that included five interns in Summer 2022 and eight in Fall 2022.

According to VyStar Chief Information Officer Lisa Cochran, students studying IT in UNF's College of Computing, Engineering and Construction can apply for a paid internship, leading to potential future onboarding as a full-time employee within the company.

The VyStar internships offer experiential learning opportunities with expert mentors and real-life assignments that help students identify their strengths and the types of work they enjoy.

Students in this program are exposed to the latest technologies and receive guidance working alongside top leaders in the industry. In conjunction with their primary assignments, the program also provides additional job shadowing and rotations to expose students to a variety of career paths in financial services technology. The lessons learned throughout different departments will allow students to provide feedback on their ideal career trajectory. Cochran said gaining real-world experience in the different technology roles is essential to future success.

"Diversity is a critical component as we solve the shortage of IT workers and as needs relating to artificial intelligence continue to evolve," Cochran said. "I hope to be a change agent to close that digital divide and ensure that everyone has the opportunity to have successful careers in technology if they have the ability and desire."

VyStar has a strong community presence working alongside numerous nonprofits and a history of supporting military, youth and countless other groups throughout Jacksonville. This inaugural IT practicum is another branch of community building for the company, as it provides vital learning

opportunities for students, while also positioning the company for future success. According to Cochran, building relationships with the interns is key not only for their real-world experience, but for VyStar as well as they continue to focus on top-tier talent in IT and throughout the organization.

# Couple helps students succeed

Fred and Susan Schantz know firsthand the value of a college degree.

Fred was a first-generation student at DePauw University and later at the University of Chicago, paving the way for his siblings to earn their own degrees. Susan studied at Duke University and later at Ohio State University to earn her Ph.D. in English, specializing in Rhetoric and Composition. Earning an education positioned them for success in their chosen fields and ignited their lifelong commitment to learning.

"It's a gift to be able to have that time just to study and prepare yourself for the real world," Susan said.

That appreciation for what they'd been given brought the Schantzes to UNF where the couple has provided significant support for the University and its students. Susan serves on the UNF Foundation board and first became involved as a member of the College of Arts and Sciences Dean's Advisory Council. In 2021, she was named an Honorary Alumna

for her incredible commitment to the University on so many levels.

The couple's support has lifted up students who are most vulnerable, including those suffering financial hardships during the COVID-19 pandemic. The two have also helped transform the UNF Writing Center with seed money to provide graduate teaching assistants and tutors. They also have funded transformative trips for undergraduates to the nation's capital with Ambassador Nancy Soderberg's Public Service Leadership Program, giving political science students an in-person view of our democracy in action. Susan describes their dedication to philanthropy as their social contract. "It's just critical to give back when you've been as fortunate as we've been," Susan said. "It's about social justice."

When considering contributions, Fred and Susan weigh the level of impact of each gift. While attending the Aspen Ideas Festival in Colorado one year, they were inspired by a Chicago foundation that provides scholarships to high-achieving students who are in great need and unable to receive government tuition assistance. Providing access to higher education for top students in Northeast Florida with unique challenges became a mission for Fred and Susan. After much coordination and planning, they created the Frederick W. Schantz and Susan West Schantz Aspiration Scholarship. A stellar Jacksonville student with outstanding grades and a strong desire to work hard and succeed was selected as the first recipient of the scholarship, which covers tuition as well as room and board throughout the student's undergraduate program.

Susan shared that she feels she and Fred have benefited far more than they have given and are grateful to be involved with the campus community. At every turn, I've met people – students, faculty, staff, volunteers, donors – who model passion for the mission, and the warm, inclusive "family" culture that is one of UNF's greatest assets.

# FY 2021 – 22 **Financial Information**






The University of North Florida Foundation provides prudent fiduciary management and oversight of the University Endowment.

The investment and management of the Endowment is governed by the Florida Uniform Prudent Management of Institutional Funds Act (FUPMIFA).


The Foundation Investment Policy:

# DONOR Bill of Rights

#### Philanthropy is based on voluntary action for the common good. It is a tradition of giving and sharing that is primary to the quality of life.

To assure that philanthropy merits the respect and trust of the general public, and that donors and prospective donors can have full confidence in the not-for-profit organizations and causes they are asked to support, we declare that all donors have these rights:

- To be informed of the organization's mission, of the way the organization intends to use donated resources, and of its capacity to use donations effectively for their intended purposes.
- II. To be informed of the identity of those serving on the organization's governing board, and to expect the board to exercise prudent judgment in its stewardship responsibilities.
- III. To have access to the organization's most recent financial statements.
- IV. To be assured their gifts will be used for the purposes for which they were given.
- V. To receive appropriate acknowledgement and recognition.

- VI. To be assured that information about their donations is handled with respect and with confidentiality to the extent provided by law.
- VII. To expect that all relationships with individuals representing organizations of interest to the donor will be professional in nature.
- VIII. To be informed whether those seeking donations are volunteers, employees of the organization or hired solicitors.IX.
- IX. To have the opportunity for their names to be deleted from mailing lists that an organization may intend to share.
- X. To feel free to ask questions when making a donation and to receive prompt, truthful and forthright answers.
